

Many Registered in Centennial Class

Registrar Reports Largest Freshman Class in Many Years.

The ninety-seventh year of Allegheny's existence was opened last week when the largest Freshman class in the history of the college presented themselves for enrollment at the Registrar's office in Bentley Hall. The trains on Monday and Tuesday brought large numbers of both old and new students, and it was soon evident that the plan to make the centennial class a large and representative one was to be realized. At the close of the first week the registration showed 348 names as against 328 for the same period last year. A total of 127 matriculated, an increase of 10 over last year. As usual the new names are from a number of states bordering on Pennsylvania. Ohio and New York both contribute a number to the list while Washington, D. C., also has a representative.

In addition to the list of new matriculations, W. R. Hofelt, E. R. English and Miss Irene Dickey have returned after a year's absence and have entered the Junior class, while Paul Robinson has entered the Sophomore class. Following is the list of matriculates:

CHANGES IN THE HIGHER POWERS.

An unusual number of changes have been made in the Allegheny College faculty since last June. Owing to the fact that Alden Academy has been discontinued, it has been necessary to have at least one extra teacher for preparatory work, thus increasing the number on the faculty.

To fill the place left vacant by the resignation of Prof. H. A. Trexler—who has gone to Johns Hopkins for further study, Dr. Gilbert G. Benjamin of New York City, has been appointed to the Chair of History and Economics. Dr. Benjamin has come to the college with very strong recommendations from Syracuse University, where he graduated in 1899, and from Yale University where he was connected with the History Department. For the past few years Dr. Benjamin has been instructor in History in the College of the City of New York. During the past year he has been lecturer in English History in the University Extension Course of the College of the City of New York and also lecturer on the staff of the University Lyceum Bureau in New York.

Professor Malcolm H. Dewey, '04, of Irwin, Pa., is acting as Head of the German Department in the absence of Dr. Mulfinger, who sailed a short time ago for Germany, where he will spend his sabbatic year in study. As an alumnus of Allegheny and a successful teacher in Irwin for some years, Professor Dewey is well fitted to assume the duties of the German Department.

Professor Lawrence Riddle of An-tietam, Maryland, is teaching French I, II, and VII in the place of Miss Hazel Bullock, who is studying in Grenoble, France. Prof. Riddle is a graduate of Johns Hopkins and has done work at Harvard, besides spending three summers in France.

Dr. R. S. Breed has returned from his sabbatic year spent in Germany and Switzerland to take charge of the Department of Biology and Geology.

Professor C. E. Decker took a course in the University of Illinois this summer, and has not returned to Allegheny.

Miss Margaret Beebe, '10, is assisting in the Latin and Greek Departments. Miss Beebe took a graduate course in Bryn Mawr after receiving her A. B. degree at Allegheny.

Professor A. W. Giles, the Geology instructor, graduated from the University of Rochester and received the degree of Master of Arts from that institution.

Cripples Play Well

Allegheny Team Holds Cornell Down to 35. Well Played Game.

The 1911 football season opened for Allegheny on last Wednesday afternoon when the squad of Captain Hawk was defeated by the strong Cornell team by the score of 35-0. Despite the large and one-sided score, the Allegheny team played well and, what is more, fought well. They never gave the game up until the final whistle and against tremendous odds played an admirable game. The Cornell tallies were made chiefly on trick plays, for on line bucks they failed to make rapid gains through the Allegheny men.

It was evident from the first that the Cornell coaches would take no chances on the possible loss of the game. The regular varsity eleven was put into the contest and the warning given to the players that the showing made by the various men in that particular game would determine the varsity lineup for the remainder of the season. The Allegheny team started out from the first to play good ball and at the close of the first quarter only one field goal had been negotiated by Cornell, making the score 3-0. At the close of the first half the tally was 14-0. The hard and consistent playing of the Cornell eleven forced Allegheny to give way more than in the first periods, so that the final score was 35-0.

It is difficult to pick out any particular man as a star as every man kept in the game right along and made his share of the plays. "Bugs" Miller and Hawk did some sensational tackling; and the work of the whole backfield was commendable. Sheffer played the whole game although a small bone had been broken in his leg in the early part of the game. The head coach of Cornell asked Coach Stewart to criticize the weak points of his team as he saw them and further expressed his approval of the game.

Sophs Win in Dangerous Fight

Freshmen Fail to Get Soph Flag Out of High Tree.

During the first week of the college year the members of the new centennial class were given their first introduction to Allegheny class spirit. The usual enthusiasm and interest brought both Freshmen and Sophomores out of bed early Tuesday night to repel the attack of the enemy. Both classes were well supplied with posters and paste and lost no time in adorning telephone poles, sidewalks and windows with their challenges and threats of dire revenge. Although neither army was prepared for any serious engagements, several scouting expeditions proved disastrous to the Sophs. After several hand-to-hand conflicts, two or three of the valiant knights of 1914 were overwhelmed by numbers and compelled to undergo a short imprisonment.

The Freshmen were somewhat outwitted on the following night, when a small group of Sophomores succeeded in posting a large portion of the town. The conflicts of the previous night which convinced the Freshmen of their superiority in strength had the effect of making them negligent. Only a few Freshmen scouts had been placed at various points throughout the town and these were unable to resist their opponents.

When the contestants arrayed themselves before the Chapel on Thursday morning, all the student body was present to encourage their various friends. Near Ruter Hall over fifty Freshmen were collected in a compact body, while but nine Sophomores could be seen at the farther end of the Chapel. It required little goading by the upper-classes to precipitate the combat. Within a moment after the first rush, every Sophomore was at the foot of the steep terrace and deeply buried in the throng of Freshmen. The Sophomores had previously—perhaps unfairly too—raised their flag in a tall tree behind the Chapel. When the Freshmen became aware of this maneuver they abandoned the old battle ground for the scene of fresh conflict. Ladders were soon procured and a desperate attempt was made to dislodge the five defenders of the Sophomore flag, who were stationed in the higher branches of the tree. Although the members of the Centennial Class fought with desperation they were unable to reach their opponents' colors before the allotted time had expired.

DEATH OF UNA K. DUFFY.

A severe shock to the college community was the sudden and unexpected death of Miss Una K. Duffy, a prominent and popular member of the class of 1911, at her home in Corry, Pa., on Sunday morning, August 13. The exact cause of her death was not known although it was generally thought to have been due to acute indigestion. The funeral, which was held in Corry on the Tuesday morning following her death, was attended by a number of Allegheny people. President Crawford took part in the service. Flowers from her class, her fraternity and other college organizations testified to her popularity.

Miss Duffy was prominent in many college activities during her course, being a charter member of the recently organized Klee-o-Kleet dramatic society, a member of the Kappa Kappa Gamma fraternity and a member of the Scientific Club.

During the coming year The Campus will be, so far as the editors and managers are able to control it, what it is. The Campus supposed to be and what it will be. It boasts of being, but unfortunately what it has sometimes not been: a representative college paper; that is, a paper which accurately and truly represents the college by whose students it is published, that is typical of the life and character of its college, and consequently is devoted to the interests of the college and its community. This is the ideal set before the present Campus board.

But in a smaller way there are other things for which the editors will strive, which, on the principle that an ideal is helped by being definitely stated and repeated, may well be set down here. The Campus in previous years has been such, from an editorial and literary point of view, that little change for the better could be made. Perhaps, however, the place where correction is most needed is in the proper proportionment of news. The Campus will have a strict regard for giving each item the space it demands and no item an unwarranted amount of space. In this connection it may be well to call attention to the fact that the editors do not entirely control the manner of presenting their news; printers' reasons are frequently the means of changing the news from its most desirable form. In the matter of typographical errors, the editors will exert themselves in a natural degree to eliminate mistakes, but not in an unnatural degree, as some have done, fearing as a terrible tragedy the entrance of a typographical error. Such things will occasionally creep into the best regulated sheets.

Several new features which require no advance explanation will be introduced into the paper. A few changes in the manner of writing and making up the paper will be made, such as continuing from one page to another as little as possible, and writing as little as possible in advance stories which purpose to have been written after an event; but these things need no comment. Above all else the editors will aim for originality, both in the literary and typographical sides of the paper's character.

Mrs. Sarah E. Cochran, the "lady elect of Allegheny," who has been profuse in her gifts to the Appreciation college, has again given of Mrs. Cochran. evidence of her generosity and lovable nature by increasing her list of liberal donations. The chain fence surrounding a portion of the campus and the new cement walks are her gifts, as also are the series of sermons which are to be delivered before the student body on Sunday afternoons once a month during the college year now beginning. If any one deserves the highest respect and gratitude of the student body, Mrs. Cochran surely does. Anything which might be said as an expression of the appreciation of the student body would be weak and much short of truthful expression; but at least it is true that the kindness of this generous lady does not pass by unnoticed or unappreciated.

A meeting of the Editorial Board of The Campus and all those who expect to compete for positions on the staff was held in the Library last Saturday. A good number of new competitors, new students and old, became evident, and the prospect is good for much enthusiastic competition for positions. Now is the time for prospective competitors to begin their work. More important even than this, is that they be consistent; for consistency, it must be remembered, is a virtue and the judges are seeking virtues as well as avoiding vices in competitors. Let the competition be of high quality and large quantity, and let it be consistently submitted.

The Adventurer

A certain person has been holding the belief for some years that, while the prime and fundamental function of a newspaper is the dissemination of news, there is also within its legitimate field a place for writing of a more distinctly literary nature than news items generally possess. Believing this, he has sought during past years to introduce into the columns of The Campus some matter of this nature; but the idea has not thrived very well, not having the commendation of those controlling the character of the sheet. The time has now come, however, when the way is comparatively clear for the introduction into The Campus of matter intended to be of a distinctly literary character. The working out of the idea will in a sense be an experiment, a venture, or a series of more or less connected adventures; and accordingly this contributor will be known as the Adventurer. From time to time he will tell here of his adventures in one shape or another. There will be no restrictions on the form of his writings; they will at one time be speculative with a slight dip into common, everyday philosophy; and again they will be narrative in form, telling of incidents or accidents which have befallen the Adventurer.

The idea of such papers as these is by no means original with this writer. The nearest prototype to what the Adventurer will aim to make them are the papers appearing weekly in The Outlook under the title of The Spectator and written supposedly by Mr. Hamilton Wright Mabie. While the articles proposed for The Campus will probably have some qualities in common with these highly literary productions in The Outlook, there will be many respects in which they will differ; these will be evident later. Many immortal writers have developed a free and easy rambling style, and it is somewhat of this quality which the Adventurer attempts to make characteristic of these writings: somewhat of the style of Isaac Walton whose words flow along easier than the running streams his fish inhabit. There are many other examples of writing of this sort. "John Percyfield," a remarkable book written by Mr. C. Hanford Henderson, has a style in many ways like that which the Adventurer would give to his column.

Such writing, with "a pleasant conversational flavor and easy discursive style," is not confined entirely to the field of professional literature, for in The Campus itself a similar department entitled "With Slippers On" was conducted with much success by Mr. B. A. Heydrick during his editorship fifteen or twenty years ago. Accordingly the Adventurer feels that in attempting to conduct a column of easy, informal discussion with no object other than entertainment, he is in no way departing from the legitimate field of The Campus.

FIRST ASSEMBLY.

H. S. Litzel, president of last year's Junior class, presided at the first assembly morning held at the regular chapel service yesterday morning. H. J. Gordon, '12, was elected Cheerleader for the year and the matter of raising a purse for "Andy" Morford was taken up. H. T. Lavelle, '12, president of the Athletic Association, explained the necessity of everyone purchasing athletic tickets for membership in the association as well as the five dollar season ticket. At the close, the new Cheerleader led the students in a college yell.

New Constitution

A new constitution for the Allegheny Oratorical Association has been drawn up by Prof. S. S. Swartley, instructor in oratory and debate, and Harrison R. Hunt, President of the Association. The new constitution is printed in full:

ART. I.—The name of this Association shall be The Allegheny College Oratorical Association.

ART. II.—The purpose of this Association shall be to foster debating and oratory in Allegheny College by holding contests in which the students of the college shall participate, either among themselves or in competition with students of other colleges.

ART. III. Sec. 1.—The membership in this Association shall be composed of all students in Allegheny College, and of all members of the faculty of Allegheny College who shall have purchased such membership tickets as shall be hereafter determined by the executive committee of this Association.

Sec. 2.—In no case shall the membership ticket entitle the purchaser to membership in the Association after the termination of the school year for which the membership ticket is issued.

Sec. 3.—Membership in this Association shall convey the power to vote at the primary and at the final elections for all student officers of this Association, as provided in Art. IV, Secs. 2 and 3, on condition that the membership ticket be presented before casting the ballot; and to vote at any meeting of the Association called to amend the constitution, as provided in Art. V.

ART. IV. Sec. 1.—The officers of the Association shall be a president, a secretary, and a treasurer. There shall also be an executive committee composed of the head of the English department, the debating instructor, and the president, the secretary, and the treasurer of the Association.

Sec. 2.—The student officers of the Association shall be nominated as follows: On a date not earlier than the twentieth day of April nor later than the first day of May, the executive committee of this Association shall meet to select candidates for nomination to the offices of president, secretary, and treasurer. A majority of the members of the committee shall constitute a quorum for the transaction of this business. Nine candidates, arranged in three groups of three each, shall be selected for the presidency. Nine candidates arranged in three groups of three each, shall be selected for the secretaryship. Nine candidates arranged in three groups of three each, shall be selected for the treasurer'ship. Each candidate must be a member of the Oratorical Association, and the name of no candidate may appear on the list twice. The secretary of the Association shall, immediately after the selection of the candidates, post a notice of the same, and also a notice of the time and the place at which the primary election is to be held, which election shall be not later than May seventeenth. In voting, each member of the Association may cast one ballot in each of the nine groups as hereinbefore provided. The candidate in each group receiving the highest number of votes in that group shall be declared nominated for the office for which he or she was selected.

Sec. 3.—The student officers of this Association shall be elected as follows: Immediately after the nomination of officers, the secretary shall post a list of the nominees, and a notice of the time and the place at which the final election shall take place, which time shall be not later than May fifteenth. Each member of this Association may vote for one of the three nominees for president, one for secretary, and one for treasurer. The nominee receiving the greatest number of votes shall be declared elected to the office to which he or she was nominated. The new officers shall assume their offices at the beginning of the ensuing college year.

Sec. 4.—In case of the resignation of any officer of this Association, his place shall be temporarily filled by a member of the Oratorical Association appointed by the remaining members of the executive committee until such vacancy may be filled by an election held in the manner provided in Art. IV., Secs. 2 and 3. Such an election must be held within two months from the time of the appointment.

ART. V. Sec. 1.—The president shall call and preside at all of the meetings of the Association and of

the executive committee; shall decide upon the time and place of meeting; and shall perform any other duties that may be delegated to him by the Association or the executive committee.

Sec. 2.—The secretary shall carry on all the correspondence of the Association, keep a record of the proceedings of each meeting, post all notices as provided in this constitution, and all other necessary notices; he shall also keep a complete list of the membership of the Association.

Sec. 3.—The treasurer shall hold in trust all moneys of the Association, shall attend to the payment of all bills and association dues, to the printing and sale of all tickets, to the collection of all door receipts at each contest held under the auspices of this Association, and he shall provide the secretary with a complete list of all who have purchased membership tickets.

Sec. 4.—The executive committee shall have the authority to propose, form, and ratify all agreements relating to oratory and debate with other colleges and universities; it shall have the power to set the date of and make all other arrangements for all oratorical and debating contests; it shall select candidates for nomination to the offices in this Association as provided in Art. IV, Sec. 2; it may also exercise all powers not delegated herein to individual officers. A majority of the members of the executive committee shall constitute a quorum for the transaction of business.

ART. V.—This constitution may be amended at any meeting of the Oratorical Association by the vote of a majority of the members of the Association present, provided that a notice of such meeting stating the proposed amendment has been posted for at least two days before.

ART. VI.—Nothing in this constitution shall be construed so as to conflict with the authority of the faculty of this college.

New Field Delayed

Montgomery Field Delayed by Storms and Strikes—Not to be Used This Fall.

The announcement that the new Montgomery Field, which is being constructed in the rear of the Gymnasium, would not be in condition for use this fall was a severe disappointment to all interested in Allegheny athletics. The heavy rains which occurred during the early part of September seriously undermined the new concrete wall and caused over two hundred feet of it to fall. In addition to this, various strikes and other labor troubles have greatly hampered the work. Although the field is being used for varsity practice, no games can be played upon it during the present season.

When Montgomery Field is completed, Allegheny will have one of the finest athletic fields in the state. The concrete bleachers, which will extend along the north side of the field, will be at least 225 feet long and ten seats high. In addition to this, a large wooden grandstand will be built near Cochran Hall. A high concrete wall

will surround the large portion of the field and prevent any trespassing. The field will be entered by a fine gate, which will be placed between Cochran Hall and the Gymnasium. This gate, which is to be beautiful in design and architecture, will be the gift of the classes of 1910 and 1911. The class of 1911 has already given one hundred and twenty-five dollars toward the gate and all the necessary money has been pledged.

The field will be used for practically all forms of out-door college athletics. The home plate of the baseball diamond will be in the northwest corner of the field. The diamond itself will be covered with grass instead of skinned. Although a large part of the southern embankment has been removed the out-field will still be somewhat short and it will be comparatively easy for a left-handed batter to send the ball over the fence. Adequate provision will be made for a track which will be used in all the class and inter-collegiate meets. Although the field is quite soft, resulting from a layer of top soil, the excellent drainage system will insure a dry, fast track, even in the most inclement weather.

ATHLETIC ELECTION.

Notice has been posted by the president of the Athletic Board that the regular fall election for the places on the Board will take place on next Saturday afternoon. There are four vacancies to be filled at this time—assistant baseball manager, assistant basketball manager, delegate-at-large, and secretary-treasurer. Nominations for the positions must be in the hands of the secretary of the Athletic Board before Tuesday. In order to be eligible to vote the annual dues of one dollar must be paid within forty-eight hours before the time of the election and must be paid in person except in case of sickness or absence from the college on permission received from the president.

Faculty in Summer

Much Activity Among Professors During the Summer Months.

The Faculty of Allegheny was unusually busy this summer in a number of places, several of the professors having spent considerable time in lecturing and special study along their particular lines.

President Crawford remained in Meadville most of the summer, being busily engaged in enrolling the centennial class and in attending to other executive matters for the college. He spent several days at Chautauqua at different times and was a prominent speaker at the Chautauqua-Allegheny banquet held on August 14.

Girls' New Contract

New Set of Rules to Govern Pan-Hellenic Rushing During Present Year.

The following Pan-Hellenic contract has been adopted for the year 1911-12, by the three national women's fraternities represented at Allegheny, — Kappa Alpha Theta, Kappa Kappa Gamma and Alpha Chi Omega:

I. No new girl shall be invited to join a fraternity until Saturday, the ninth of December, the bids being mailed so that they will be received by the new girls at noon. No girl shall be invited to join a fraternity unless she is carrying twelve hours' work at Allegheny and maintaining an average of at least C in three-fourths of her studies and a passing grade in all.

II. Answers to invitations shall be in writing and shall be presented to one member of the fraternity from whom information can be obtained. All unaccepted invitations shall be returned.

III. Older girls shall not be with new girls on "bidding day," and there shall be no communication whatever to the new girls on fraternity matter until answers are received.

IV. A copy of the contract shall be sent to all interested alumnae and friends, and every girl of the Freshman class and published in The Campus early in the term. Each chapter shall be responsible for its active girls, alumnae and friends.

V. There shall be no rushing whatever by active girls or alumnae. By "no rushing" the following is understood:

1. No fraternity or member of a fraternity shall have a new girl at a party or spread.

(a) No fraternity girl shall be present at a spread where a Freshman girl is, unless permission has been obtained from the Pan Hellenic Committee.

(b) No fraternity girl shall be cut in company with a Freshman girl and a man.

2. No money shall be spent on a new girl.

3. No fraternity or fraternity girl shall monopolize the time of any new girl.

4. No dates shall be made with a new girl, and no new girl shall be off the campus with one fraternity only, more than twice a week.

5. No new girl shall be allowed out for a meal with any fraternity girl, alumnae or friend of the fraternity.

6. No fraternity girl shall be with a new girl after bells or before rising bell.

(a) No fraternity girl shall be with a new girl for more than half an hour a day during study hours.

VI. During the first semester, a party shall be given by the three fraternities for all the new girls.

VII. All complaints, of any nature whatever, shall be presented to the Pan-Hellenic Committee through the representatives only, who shall have power to impose penalties.

VIII. The Pan-Hellenic Committee shall have a definite, regular time for meeting.

IX. The committee on College Organizations shall be advisory members of this committee.
