

LOCAL FIVE TAKES EASY GAME FROM MT. UNION

Visitors Unable to Get Near Basket.
Final Score 53-6.

Allegheny more than retrieved the foot ball defeat at the hands of Mt. Union-Scio last fall, when on last Friday night the 'varsity triumphed over the Ohioan Methodists by a score of 53-6. By the one-sided score it can be readily seen that the local five had little trouble in combating the opposing forces, for the visitors at no time proved dangerous, although in the beginning of the first half they held the Allegheny five scoreless for a few minutes and showed a little team work. However, in the first half, after a few minutes of play, Mates connected with the basket and from that time on the scorer was busy chalking up points for Allegheny. Mt. Union worked hard, but it was of no avail, for the superior shooting ability of the 'varsity evidenced itself time and again and the Allegheny guards covered up the blue and white forwards to such an extent that they hardly had an open shot at the basket. During this period Mates found the ring eight times and easily proved himself to be the "shooting star" of the game. Hawk was opposed by Mt. Union's strongest man and had little opportunity to do any shooting, although his floor work was exceptionally fast. In addition to the stellar work of Mates, Nichols contributed four field goals, Thomas and Graham one apiece, while Hawk got four fouls out of four chances, thus ending the first half 32-1. Mt. Union managed to get its only point on a free throw by Blythe.

The second half was considerably slower than the first and continued fouling was especially in evidence. The gold and blue missed many chances at the basket, while the work of Mt. Union seemed to pick up, for in this period they managed to get their only field goals of the game, one a long shot by Blythe and another by Wilson. In this half Hawk broke away from his man for two field goals, while Mates, Thomas and Graham each added one. Towards the close of the period Cox, Lindberg and Dunbar were substituted and they all added materially to the total score. Dunbar was in his first 'varsity game and his work at guard showed much promise.

THIRTEENTH ANNUAL COLLEGE DINNER HELD IN GYMNASIUM ON SATURDAY

Over Four Hundred Present at the Banquet—Usual Class Rivalry
Features Program—Class Decorations Elaborate

The Thirteenth Annual College Dinner connected inseparably with Washington's Birthday was held Saturday evening, in the Gymnasium. For splendor in decoration, college and class spirit manifested, excellence in speaking, catchiness in singing, novelty in effects and stunts, and the enthusiasm among all present for the occasion the banquet this year was easily the climax of the events of this kind that have been taken place since the inauguration of the affair.

Nearly five hundred students, Alumni and friends gathered together in the Gymnasium in the honor of the father of our country, the largest crowd ever present at the annual College Dinner. The capacity of the Gymnasium was more than taxed with the tables of the banqueters, necessitating the committee in charge to limit the number of guests present. The Alumni had an unusually large number present and had one large table completely filled with the members of the previous classes. A number of guests and prospective students were also in attendance. The gallery also was filled with visitors who came to hear and see evidences of the real Allegheny spirit.

The decorations among the many other things showed a great advance over any preceding year. As a background for the schemes which the different classes wished to introduce, the building as a whole was draped with streamers in the national colors. These were fastened at the center of the ceiling and gracefully fell to the edges of the balcony. At the ends of the rooms were large portraits of George Washington and Timothy Alden, the founder of Allegheny college. The classes occupied their places assigned in the four corners of the room, the Juniors and Freshmen being in the left hand and right hand corners respectively as one enters the door, while the Sophomores and Seniors were directly opposite. The toastmaster's table was on the north side between the Junior and Sophomore divisions, and in the center, and between the Juniors and Freshmen were several other tables for Faculty and Alumni and invited guests.

The Seniors, on account of the unusually large number present, could not be allowed the extra room required for the platform upon which the graduating class has heretofore been honored with seating, and this feature was necessarily done away with. Their corner was enclosed with a festoon of evergreen in which sparkled numerous small electric lights. Around the wall the class colors, scarlet and gray, in banners and paper decorations, were artistically arranged. Red roses were placed in among the green branches and were well set off by the dark foliage. The whole presented a scene of natural beauty and still was one of the most brilliant spots of the evening. All Seniors wore black caps and gowns, as this is the occasion on which by right of tradition the class makes its first appearance in the graduating costumes.

The Juniors in the opposite corner also wore caps and gowns, but their's were of white with a purple hood, purple and white being the class colors and the white gown being the distinctive Junior costume. They sat within a booth made up of a criss-cross design with purple and white streamers. For novel effects this class showed it had not lost its earlier spirit. Above the tables on the edge of the balcony was suspended a large box which at first dimly evidenced the numerals 1914. When later at a given signal all other lights in the room were extinguished these figures were made to stand out in great prominence by a large light behind them, making a very pretty sight. Again at a signal hitherto invisible banners were unfurled bearing words signifying Junior preeminence.

Of all displays the Sophomore was probably the most artistic. The whole scheme of decorating and costuming was based on the Greek idea. All the class wore the long white flowing robes of the ancient Greek girdled by a scarlet cord, and on the head of each was a classic green wreath. A pretty and significant effect was produced when the class on its march around the room placed these wreaths upon the brows of the Seniors. The Sophomore section was set apart by a number of Corinthian columns bearing at their tops the Greek key designed in scarlet on canvas and serving as a cornice. There was little further decoration than this, in keeping with Greek idea of simplicity.

The Freshmen on the other hand were very elaborate both in costume and decoration, but this in no way detracted from exceedingly pleasing effect. The underclass colors in accordance with precedent were for the first time displayed; it is needless to say that the Freshmen made very good use of the opportunity. Their three long tables were surrounded by a system of high railings wound with orange and black paper and spotted at intervals with rosettes in the centers of which were electric lights. The background was a pretty arrangement of a large 1916 banner and a large number of small ones. For novelty the Freshman costumes probably excelled any that have been seen at a banquet of this kind. The girls represented "Little Bo-Peep" and wore dainty dresses and caps, while the men carried out the companion part of "Little Boy Blue." The girls carried decorated shepherd's crooks and the boys small tin horns. On the costumes of both were narrow sashes of twisted orange and black ribbon, indicative of their class since the costumes were necessarily of other colors.

One of the Freshmen stunts was the hoisting of a dummy bearing the numerals 1915, and dressed in Grecian style which caused some merriment at the expense of the Sophomores who seemed a little taken back at this unexpected move of the lower classmen.

The songs of the evening far eclipsed anything that had been heard at a previous banquet. During the course of the banquet, each class in order of seniority stood up and let "music fill the air." All the class incidents of the past year were referred to in the most witty way. Even the Faculty came in for its share of knocks. The singing of the Freshmen again was a commanding feature and the neophytes had one song, the music and words of, which had been composed by one of their own members. After the dinner had been finished and before the toasts began, the Sophomores marched around the Gymnasium in review before the other classes, Faculty and Alumni present. The Freshmen in turn marched around in review, while the various classes created a pandemonium of noise.

Dr. G. A. Mulfinger, the toastmaster of the evening, brought the assemblage to order with an Allegheny song after which Dr. F. C. Lockwood invoked the divine blessing. Then the singing of the various classes began, the underclasses delighting in challenging each other. A number of telegrams were read from various Alumni scattered about the country. One greeting was read from Dr. Crawford who wished the best success for the occasion and regretted that he was unavoidably detained in New York City. After this Dr. Mulfinger presented the speakers of the evening in very happy introductions and prefaced the toast list with an entertaining account of incidents in the life of George Washington and Timothy Alden.

The first speech of the evening was made by Principal Frank E. Baker,

Ohio Wesleyan Next

Strong Ohio Team to Play Here on Friday Evening.

The strong Ohio Wesleyan five will come to Meadville on next Friday to meet the gold and blue in the local gym. This will be undoubtedly the stellar attraction of the present season, since the Ohioans administered the only defeat of last year's schedule when they won at Delaware by a score of 17 to 28. Two years ago they broke Allegheny's enviable record of nine years without a defeat on the local floor when they took the gold and blue into camp by the close score of 18-16. Last year the opening game was won here from Wesleyan 41-11. From this record it can be easily seen that Allegheny will have her hands full on next Friday night. This year the Wesleyan five has had an exceptionally brilliant season, as contenders with Ohio State for the state championship. From press reports Wesleyan have the best chance of winning out, for they have already defeated Oberlin by a margin of ten points.

The Cleveland Plain Dealer, of Monday, under the head of "Wesleyan Boasts of a Star Quintet," thus tells of Wesleyan's chances for a state championship:

"With Ohio Wesleyan, Ohio State and Oberlin towering far above all other conference fives, the basketball situation in Ohio intercollegiate circles is gradually coming to a head. Wesleyan stands within the shadow of the championship flag, at present, having defeated every opponent so far in the race, but with State and Oberlin still before her. Without a doubt, the Wesleyan five, under the tutelage of Coach Banks, has shown the most class on the floor. O. W. U. has a collection of individual stars who have developed team play to a wonderful stage of perfection. Little, Gates and Higgins are to be classed among the best floor men in Ohio.

"On March 1, O. S. U. comes to Oberlin, followed on March 8 by Ohio Wesleyan. These games will veritably settle the state championship. Victory by Wesleyan should give the Delaware five a clear title. Victory for State would tie up State and Wesleyan, while two victories for the Congregationalists would tie up the three big powers in Ohio intercollegiate basketball. Oberlin has a chance of winning both contests and an undisputed championship."

Interclass League

Two Good Games in the Schedule
Played Last Week.

The interclass basketball league started off very auspiciously when on last Saturday afternoon the four classes of the college lined up against each other in the first two games toward the championship. In the first contest the Sophomores triumphed over the Seniors by a score of 19-9, while in an extra period game the Freshmen defeated the Juniors 21-17. The rooting at both of these games was of the spirited variety and the participants were urged on by their respective classes to extend themselves to the utmost. The Sophomore-Senior contest started off with some fast basket ball and before the "Centennials" could locate the basket, the Seniors had scored six points. Later in the period, last year's champions struck their stride and the half ended 10-6 in favor of the underclassmen. The second period was characterized by a great deal of rough playing and not such good basket ball. The lack of practice soon began to tell on the upperclassmen and it necessitated the removal of several of the best players on account of "poor condition." The Sophomores managed to get nine points to the three of the Seniors, thus ending the game, 19-9. Owing to the large number of Seniors on the present Campus board and owing also to the Competition fact that competition Still Open this year has been limited to a smaller number of men, there is still an opportunity for several persons to make places for themselves on the Campus board for 1913-14. However, as competition closes about the first of May, it is necessary that persons desiring to enter should begin at once, as the constitution governing the Campus board requires that each member of the board submit the equivalent of a certain amount of material before a certain date. Any desiring to enter at this time should see the editor at once.

In this column last week, comment was made on the present college council and its position as an unrepresentative body. The intention at that time was not to give the suggestion that the present body was more unrepresentative than that of previous years, but rather to point out that a body with its members chosen in such a manner is not representative of school activities and of the college in general. It has no regular time or meeting; no defined duties and no course of action outlined for it—and hence meets only occasionally and then only for business of minor importance. Membership in the club is hardly to be classed as a college honor, while in most schools, where a student senate is in existence, membership in that body is considered one of the most distinguished honors. Under the present system, membership in College Council can be considered little more than for the purpose of seeing that your own toes are not tramped on.

At a meeting of the men of the upper classes some time ago, a committee was appointed, the duties of which included the drawing up and framing of a plan that would provide a more representative body for the student interests. If this is to be dropped here, nothing will ever be done, but if the plan is to be worked out, it should be done at an early date. The Campus would suggest a plan somewhat as follows: Each organization should have a representative, including the various classes, but not based on fraternity and non-fraternity interests. These should constitute a body with power to act on various college questions and should present to the student body certain plans which will aid the student interest and thus directly the interests of the college. Space does not permit a complete description of a system, but we feel sure that a plan—so arranged and with the members elected in a similar way—can not fail to be representative of the college interests. The editor will welcome communications or suggestions of plans.

PHI KAPPA PSI FOUNDERS' DAY.

In honor of the founding of the Phi Kappa Psi fraternity, Founders' day was observed in all of the seventy-four chapters, throughout the nation and in keeping with the anniversary Penna Beta chapter held a banquet at the fraternity house on North Main street Wednesday evening. The banquet consisted of ten courses, and the banqueters surrounded the tables at shortly after 7 o'clock.

There were about fifty present, and after the delicious menu had been served, Ben. R. Beisel, '14, as toastmaster, in a few neat words, spoke of the happy occasion, of the guests not present for the evening, and called upon Ben. F. Miller, city engineer of Meadville, as the first speaker of the evening. He responded to the toast, "Fraternalism." J. D. VanHorne, '13, followed with a toast on "Ideals"; Dr. G. G. Benjamin, New York Beta, "Realities"; F. L. Mechlin, '13, "Scholasticism"; LeRoy Peterson, '13, "Tomorrow."

Following the interesting toasts, extemporaneous remarks were made by a number of the alumni members present, including Bishop James M. Thoburn, '57; John O. McClintock, Esq., '72; Manley O. Brown, Esq., '91; Dr. C. C. Laffer, '89; President Frank Baker, '05, of Edinboro Normal and Prof. Francis LaBounty, '07.

PRESIDENT CRAWFORD TO SPEAK AT CELEBRATION.

In the Pittsburgh Dispatch of Friday, February 21, a cut of President Crawford, together with President E. E. Sparks, of Pennsylvania State College, and Provost E. F. Smith, of the University of Pennsylvania, appears on one of the pages under the title, "Many Notables to Attend." President Crawford has been invited by the authorities of the University of Pittsburgh to be present at the 126th anniversary of the granting of the first charter by the state to the old Pittsburgh Academy, from which the University of Pittsburgh sprung. The following is taken from the Dispatch:

In the evening the annual Alumni Charter Day Banquet is to be held at the Schenley Hotel. Prominent state and college officials are to be present at the exercises and the banquet, and several of these will make addresses, including Provost E. F. Smith, of the University of Pennsylvania, President E. E. Sparks, of Pennsylvania State College, and President W. H. Crawford, of Allegheny College. President Crawford will speak on "The College and the University." The student celebration will be held in Soldiers' Memorial Hall, beginning at 10:30 in the morning. Members of the Alumni Association will give historical reminiscences of the university. The formal celebration will take place at 2:30 in the afternoon, in Memorial Hall. Preceding the exercises the faculty will form an academic procession and, led by the University Band, will march from State Hall to Memorial Hall.

DR. F. T. STOCKTON, '07, AT MODERN PROBLEMS CLUB.

Tonight the Modern Problems Club has as its guest Dr. Frank T. Stockton, '07, now instructor in Economics at Rochester University, who will speak to the Club and a few invited guests on the subject, "Currency and Banking Reform." Dr. Stockton, since his graduation from Allegheny, has made a fine reputation for himself as an authority in his line. He first spent some time at Johns Hopkins University from where he was called to his present high position at Rochester University. He has been in Meadville several days, having been present at the banquet Saturday night, and has spent the time in visiting old friends.

BLASDELL LEADS MEETING.

The weekly Y. M. C. A. meeting was held in the Association Room at Cochran Hall on Wednesday evening. The meeting was in charge of D. J. Blasdell who spoke on the subject of "How Can the College Man Accomplish the Greatest Good?" In the development of the subject, the leader went on to show that since the college man has the greatest opportunities due to his training, he, above all others, should be productive of the finest and the truest thoughts and ideas, even as a tree receiving the best care produces the finest fruit.

Owing to several unforeseen conflicts the attendance was unusually small but in spite of this the meeting was an enthusiastic one, several responding to the president's invitation to take part.

PRESIDENT CRAWFORD SPEAKS AT DAY OF PRAYER SERVICE.

The Day of Prayer for Colleges was observed Sunday afternoon by a fitting service at which President Crawford spoke. He first read a few verses which contained the Lord's Prayer. "There are two things," he said, "in college life that we ought to think about. The first is college spirit. That is good and worth while, and there is nothing that differentiates one college from another more than just this. Then, second, there is the spirit of the college. That is totally different from college spirit. Two things cannot be imagined further apart than these two." He then explained the purpose John R. Mott had had in mind when he sent out the call for the Day of Prayer, that of solving the question, "How the College relates itself to the Things that Most Need Doing?" The Call was read and Dr. Crawford pointed out the prominent features.

"There are three paths which we must at times tread in this world: the clear path, the blocked path, and the doubtful path. When the way is blocked or doubtful we have recourse to prayer, that our path may be made clear. There is a great power in prayer. But prayer should be offered in a secret place, away from the enticements and diversions of the world. There is something about the closed eye and seclusion which perhaps we do not fully understand now, but sometime we shall understand. It is a wonderful experience to be absolutely alone with God, and to talk and plan with him.

"Recognizing this wonderful power of prayer, the Students' Federation issued an urgent appeal to the students all over this country to join in interceding for those things which make for the betterment of conditions in the world today.

"The present is a time of unique religious opportunity among students throughout the world. For the first time in history the universities of nearly all lands are friendly to the ministry of the representatives of Jesus Christ. It is also a time of great danger in the student world. There are many startling evidences of moral collapse and of decline of religious belief. The influence of materialism, rationalism, and agnosticism is felt in the colleges as possibly in no other communities.

"It is evident that this is a time of peculiar urgency. If the many doors of opportunity throughout our whole student world are to be entered while they are still open, the Christian forces on behalf of students must be mightily energized by God as a result of the prayers of many of the followers of Christ.

"Reminding ourselves, therefore, not only of the need of prayer, but also of the character of God, let there be faithful intercession unto Him who is the same yesterday, today, and forever, able to do exceedingly abundantly above all that men ask or think."

"There were also six reasons for intercession—that there may be raised up more evangelistic and apologetic writers; that the newly-formed student movement may be guided; that the tour of Secretary Mott in the Far East may be of great aid; that the Conferences of students at Lake Mohonk and at Princeton may mark great advance in the work for students; that money may be forthcoming for the work; that all efforts by Christian churches to relate students, as graduates, for Christian work may be extended." He added also that the great need for more and better young men for the Christian ministry and the need for more and better young men and women for the foreign and home missionary posts might be fulfilled.

Dr. Crawford called for a number of prayers as a fitting close for the service. Mr. Rose sang well a sacred solo at the beginning of the hour.

The legislature of Virginia has rejected a bill proposing to make the University a co-educational institution.

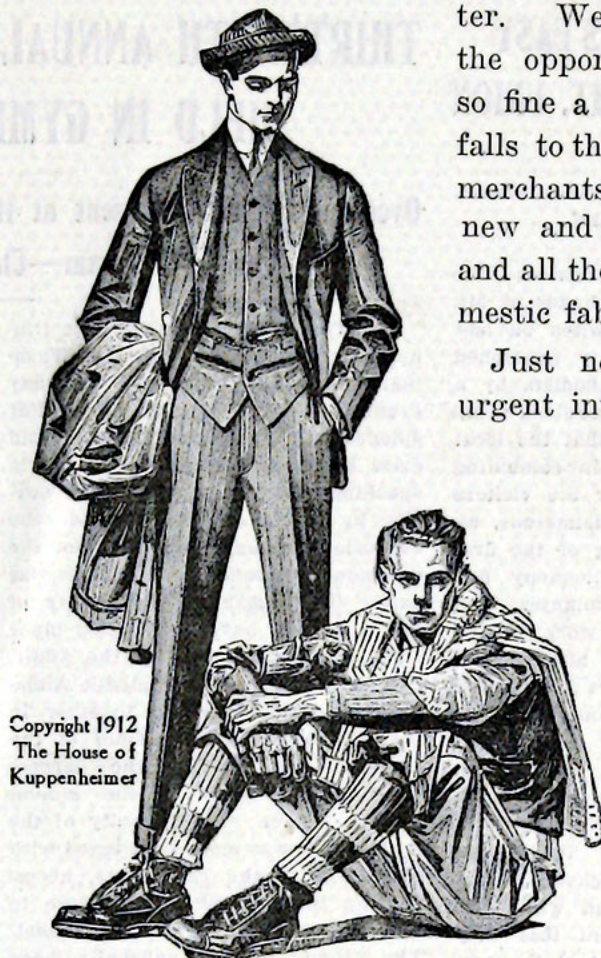

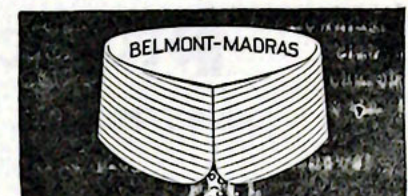

COMPETITIVE MANAGERSHIPS.

In support of the recent articles which have appeared in the Campus regarding the competitive system for the election of managers of athletic teams, I desire to present what I have learned of the workings of this system at Cornell as well as Colgate. I am more familiar with the Cornell system and believe it could be so altered as to meet the demands now existing at Allegheny.

At Cornell, and also at Colgate, the executive powers of the system are vested in a students' association or senate. Our College Council, modified perhaps as suggested in an editorial in last week's Campus, with proper faculty representation, could discharge the duties of this body quite efficiently. In a larger sense practically all the managerial or equally important offices of student organizations could be placed under this council. This would include publication managers, Glee Club managers, presidents of dramatic clubs, etc.

Take for example the competition for football manager. With the opening of the fall term the football manager could issue a call for competitors from the Sophomore class, the successful candidate becoming assistant manager in his junior year and manager in his senior year. I believe the office of assistant manager should be retained so he could go ahead the preceding fall to his managership and negotiate with foreign managers or assistant managers for the following year's games. He would be relieved of the laborious details by the competitors and could come into intimate touch with the manager and profit by the latter's experience. If the successful candidate became manager at once, he would be but one of six or more candidates and hence could not negotiate with outside teams in arranging the following year's schedule, nor profit by as intimate relations with the manager as an assistant manager would.

Assuming further for illustration, that one competitor would respond from each fraternity and perhaps two non-fraternity men. The manager could outline the competition to them, which would close with the Christmas vacation. Credits would be awarded on some definite basis. If the present system of every student buying a season ticket should be discontinued, credit could be given for the number of season tickets sold. If the system is retained credit could be given for the sale of tickets to down-town people, which would stimulate revenue from that source. The vacant afternoons of each competitor could be ascertained, and satisfactory afternoons could be assigned to each competitor, who would be responsible for the discharge of the managers duties on the respective afternoons. The placing of advertising, lining of the gridiron, looking

after suits, and dozens of other duties would come up at the proper time for further assignment and competition. At the end of the week the manager and assistant manager and coach could meet and give credits to the men in proportion to the efficiency of their work. The collecting of suits, their cleaning and caring for after the football season closes would end the competition. At Cornell credit is also based on office work where candidates write letters and assist in the correspondence of managers.

At the end of the competition the assistant manager would be chosen by the present manager, assistant manager, coach and faculty representative, after a careful examination of the work done by each competitor. This would be similar to the election of the editor-in-chief of the Campus.

This plan could be as easily, or perhaps more easily, applied to basketball, track and baseball and the details worked out in each sport. It seems very reasonable that the most efficient man would be secured for manager and at the same time every man or organization in college would stand equally in securing the office. At the same time the heavy duties of the manager and assistant manager would be relieved from the shoulders of two men, or as it is in some cases, from one man. This would not necessarily make any change in the duties of the present Athletic Board. It might be more practical to have the competition in charge of this board, as it would be composed of managers who have passed through the experiences of competition and fully understand its problems.

The need of this or some similar system is apparent at Allegheny College, and is being adopted by many of the colleges and universities of the country. It meets, I believe, with the hearty approval and support of the faculty, and its adoption should be a matter of as little delay as possible.
